- 1. Sarah Zelikovitz explained to the Committee that the majority of the curriculum proposals passed at the May, September, and October meetings have yet to be approved by Faculty Senate. Issues of credit counts in the major and course credit/hours sparked a long discussion at the October Faculty Senate meeting. Ralf Peetz addressed the Committee this morning and relayed that the Provost feels that the curriculum resides with the faculty. At the Faculty Senate meeting, some expressed concerns that several majors require too many credits leaving little or no flexibility for students to explore other areas of study. Ultimately, if courses/programs are proposed, the President will decide what is reported to CUNY. Ralf Peetz suggested that an Ad Hoc Committee be created to discuss these issues and perhaps develop best practices and/or policies on course/program development moving forward.
