- 1. The agenda for November 5th was unanimously approved.
- 2. The approval of the minutes from the October 1st were unanimously approved.
- 3. Proposals from the Department of Physical Therapy for:
 - a. Change in existing course: PHT 887 Clinical Decision Making was unanimously approved.
 - b. Change in existing course: PHT 770 Evidence Based Research I was unanimously approved.

7. New Business: Mel Pipe reminded the committee that there will be a Middle States visit in 2020. In addition, she shared that at the Provost/Deans Council it was reported that there was a drop in Graduate enrollment. She asked the committee to share of any new program developments in the pipeline or best practices in terms of student recruitment. The School of Education reported that the fully-online TESOL program and Bilingual Extension have been approved by NYSED. In addition, the Leadership in Education program is now accepting early admission for their upcoming summer program. The Social Work Department is advertising to targeted audiences. They are interested in increasing their student cohorts but must adhere to faculty/student ratio of their accrediting body. In order to admit more students, they will need to hire an additional faculty member for the program. The Physical Therapy program echoed same enrollment limitations due to their accreditation. They intend on introducing a DPT/PhD program in the near future. The English program has seen an increase in their program enrollment. The best practices included answering email inquiries and allowing the students the option to teach at the undergraduate level.
